Approximately 450 children served through a variety of 7 resident choirs and a satellite choir program consisting of 9 choirs. The Cincinnati Public Schools (CPS) Honor Choir is an annual program that consists of 80+ CPS students, from 23+ different CPS schools, combining forces and performing with the CCC award-winning Bel Canto Choir in concert.

4b (Code:) (Expenses \$ 34,384. including grants of \$ 3,170.) (Revenue \$ 22,050.) Summer Festival Program - Children participate in a week of choral music education and performance at a festival held at the University of Cincinnati. Approximately 200 participants have an opportunity to learn from prominent clinicians and develop camaraderie with peers from the community.

4c (Code:) (Expenses \$ 62,346. including grants of \$ 2,730.) (Revenue \$ 73,723.) Queen City Choir Festival - 4 to 6 children's choirs from across the country are hosted by the CCC Con Brio Choir for a three day festival held at the University of Cincinnati with education, performance and activities around the Greater Cincinnati area.
