The Cincinnati Public Schools (CPS) Honor Choir is an annual program that consists of 80+ CPS students, from 23+ different CPS schools, combining forces and performing with the CCC award-winning Bel Canto Choir in concert.

4b (Code: ) (Expenses \$ 26,266. including grants of \$ 2,100. ) (Revenue \$ 16,350. ) Summer Festival Program - Children participate in a week of choral music education and performance at a festival held at the University of Cincinnati. Approximately 200 participants have an opportunity to learn from prominent clinicians and develop camaraderie with peers from the community.
